

Retired Lawyer WW I Pilot Was

Earl F Boxell. 92, of Sherwood Forest Manor, died Friday in Darlington House, where he lived since

Born in Marion Ind he came to Toledo in 1923, where he joined the law firm now known as Fuller & Henry

Before attending coffege in 1916. Mr. Boxell taught School for three years in a one-room schöolhouse near Marion

politics, serving as city council president from 1975 to 1959, and as a council member for 10 years denoting 1955 to 1959, and as a council member for 10 years. He helped draft the charter which transformed the village into a city and, consequently, served as vice chairman of the Maumee Ohio Charter Commission. He had the ter Commission He also_helped

ter Commission He also helped draft that city's payroll income tax. Mr. Boxell fought for the Ohio turnpike to be diverted south of Maumee. Although this effort was unsuccessul. Mr. Boxell had a hand in gaining turnpike commission agreement to build the roadway below surface level.

During World War I. Mr. Boxell was an aviator in the U.S. Army Signal Corps. stationed in this country awaiting orders for overseas service. He attended ground school at both Ohio State University and the University of California-Berkeley, and was commissioned a second

the University of California-Berkeley, and was commissioned a second lieutenant in May, 1918.

He earned his undergraduate degree from the University of Michigan, where he was also awarded a law degree with distinction. While at the university, he was a member of the Law Review, the Board of Student Editors, and the Order of the Coif, an honors society.

In 1941, he became one of the founding partners who established the law firm now known as Brown.
