Elfrida G. (Hurst) Reiter Dunn, 87, of Bowling Green and formerly of Rossford and East Toledo, died Wednesday, February 26, 2003, in Flower Hospital. She was born January 7, 1916, in St. Catherine's, Ontario, Canada, to Col. George and Jennie B. (Carey) Hurst. At the age of nine, Elfrida moved to East Toledo with her family, and in 1934, graduated from Waite High School. In May of 1935, Elfrida married John Reiter who preceded her in death on March 7, 1973, and in June of 1978, married Clifford J. Dunn, who preceded her in death on June 16, 1998.

For many years, Mrs. Dunn was a receptionist for Dr. Robert Goulding and had volunteered at the East Toledo Family Center, formerly known as the East Toledo Neighborhood House, where she was inducted into the Distinguished Alumnae Hall of Fame in April of 2002. She was a current member of St. Paul's Episcopal Church in Maumee, and a former member of Trinity Episcopal Church in Toledo. Elfrida truly loved people and was active in various community groups and volunteer groups including the PTA, Order of Eastern Star, and she currently served as president for the assisted living group at Alterra Sterling House where she resided.

She is survived by her sons, Stanley J. (Raquel C.) Reiter of Jerome, MI and Edward J. (Linda S.) Reiter of Bowling Green; daughter, Pamela J.
